The Chamber of Forest Engineers of Turkey is a non-governmental organisation established with the line of Turkish Constitution to represents its members. According to the Turkish Constitution it has a special status. It has "public corporate entity" and according to the relevant legislations it has "public institute nature". Chamber of Forest Engineers of Turkey was founded with a law enacted by Parliament.

According to the related Law, the "Chamber of Forest Engineers" is the legal representative of three different professional groups.

These;

- a) Forest Engineers,
- b) Forest Industrial Engineers,
- c) Woodworking Industrial Engineers.

A large number of its members work in forestry related departments of the Ministry of Agriculture and Forestry.

These Institutes are as follows;

- a) General Directorate of Forests
- b) General Directorate of Nature Conservation and National Parks,
- c) General Directorate of Combating Desertification and Erosion.

In addition, there are members working in public institutions such as General Directorate of State Hydraulic Works and General Directorate of Highways. On the other hand, there are members working in their own workplace and working in private sector companies. The Chamber of Forest Engineers is working hard to be an active player in the international arena in addition to its activities in Turkey. Today, it is the president of the "Council of European Foresters" which it members reach to around 60 thousand.

In line with this context, we attach great importance to our membership of the "Union of European Foresters and here I would like to share our satisfaction to be here with your distinguished colleagues.

This year, the Chamber of Forest Engineers is participating with a team of 3 people.

**President Hasan TÜRKYILMAZ** is the president of both the Chamber of Forests Engineers and the Council of European Foresters. Hasan TÜRKYILMAZ, who was elected as the as the "Chamber of Forest Engineers" in April 2018 and President of "Council of European Foresters" in August, is also the Chief Inspector of the General Directorate of Forests of Turkey. On the other hand, he is still working as the "Senior Agriculture and Forestry Expert "at the General Directorate of Nature Conservation and National Parks, an institution of the Ministry of Agriculture and Forestry. Previously, he served as Deputy General Manager in charge of Forestry and as the President of Committee of the Mediterranean Forestry Questions-Silva Mediterranea" which is body of the FAO.

As the Chamber of Forest Engineers, we care about the "Union of European Foresters" and would like to express our desire to work more actively, our willingness to take part in institutions and our desire to host various meetings.
