## Dear Mr. Calderon,

It was my pleasure to meet you in person during the "International Scientific and Practical Conference on the topic "Sustainable Management of Mountain Forest Ecosystems in the Context of Climate Change" dedicated to the 75th anniversary of the forestry of the Kyrgyz Republic" held in Bishkek, on September 15, 2022.

As the President of the Chamber of Forest Engineers of Türkiye (OMO) I am pleased to submit my application to be a "partner organization" of the Asian Forest Cooperation Organization (AFoCO) in line with your "Rules of Procedures for Partners Countries and Partner Organizations of the Asian Forest Cooperation Organization".

OMO, a non-profit NGO, was established under the Turkish Engineer and Architect Chambers Union Law in 1954. OMO is a corporate body and a professional organization operates in line with the Turkish Constitution. It is the legal representative of three different professional groups: Forest Engineers, Forest Industrial Engineers and Wood Products Industrial Engineers. Currently it has almost 20 thousand members.

We reviewed your webpage, your documents and your projects, also your vision. I am pleased to explain that OMO shares the same or close visions. As OMO we also work on the issues as climate change, biodiversity, ecosystem restorations.
