1. Opening of the meeting

The meeting will be opened and chaired by the representatives of Germany, the chairing country of the FOREST EUROPE process. Sweden has accepted to be the co-chair of this meeting. The meeting will be held in-person only and in English.

2. Adoption of the agenda

In accordance with the established procedure, the chair of the Expert Level Meeting shall, at the beginning of the session, introduce the draft agenda and ask for its adoption.

3. Membership in the GCC from 2025 onwards and funding of the process

Following the kind announcement by the United Kingdom and by Albania at the last ELM in Bonn (9/10 January 2024) to become GCC members from 2025 onwards with the precondition that the new working modalities will be approved, a formal decision will be prepared to present this decision to the 9th Ministerial Conference.

Sweden will provide an update following their announcement at the last Expert Level Meeting if the country would be able to chair the process from the beginning 2025 onwards.

4. Preparation of the ninth Ministerial Conference (MC9)

Following the intense discussions at the last Expert Level Meeting in Bonn and based on the written procedure by FE signatories and observers (19. February – 2 April 2024) the Liaison Unit Bonn with support from the GCC has developed the final drafts (version 3). It is foreseen that signatories and observers will have a last check of the documents and agree on the remaining open points. It is the joint understanding that the Ministerial documents will be finally approved by this Expert Level Meeting with the agreement that this version will be presented to the Ministers at the 9th Ministerial Conference for signature. No further amendments will be allowed after the Expert Level Meeting.
